The undersigned is directed to convey the Government's sanction of deputation and study leave to Mr. Arifuzzaman (ID No. 16797), Officer on Special Duty (Senior Assistant Secretary), Ministry of Public Administration for attending the Doctor of Philosophy Course at the University of Queensland, Australia from 15.10.2023 to 14.10.2027 under the following terms and conditions:

- a. The approved period of this course and the time spent for travel and transit will be treated as on duty;
  - b. He will draw all parts of his pay and allowances in local currency;
  - c. All expenses related to this program will be borne by the 'Prime Minister Fellowship 2023-24' Program and by himself;
  - d. He will not be allowed to stay abroad for more than the approved period;
  - e. His deputation period is from 15.10.2023 to 22.07.2026;
  - f. Duration of his education leave (on half average pay) is from 23.07.2026 to 14.10.2027;
  - g. **The provision of Appendix V and Rule 194 of BSR (Part-1) and provision of Rule 34 of BSR (Part-1) will be applicable in connection with this approval;**
  - h. He will not be allowed to stay abroad for more than the approved period;
  - i. He will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of his return to Bangladesh after completing the course;
  - j. **He is ineligible to apply for permanent residency and citizenship while studying abroad;**
  - k. All terms and conditions of PATP-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
