(c) BDT 39,60,000.00 (Thirty Nine Lac Sixty Thousand) (Maximum) will be provided for Master Program from the "Capacity Enhancement of the Core Courses of BPATC" project being implemented under BPATC, Savar, Dhaka and sponsored by DRGA-CF, Government of Japan;

(d) He will not be allowed to stay abroad more than the approved period;

(e) After completion of the course he will have to submit an Individual Action Plan (IAP) and all bill vouchers related to this overseas study to Bangladesh Public Administration Training Centre, Savar, Dhaka;

(f) He shall sign a bond in a prescribed form before hir departure;

- (g) The Selected Government Officials shall depart the country before the date mentioned in this GO. Otherwise this GO will be treated as null & void. In that case alternative candidate will be considered and the previous candidate shall return all the Government money;
