- She will not be allowed to stay abroad more than the approved period; (d)
- After completion of the course she will have to submit an Individual Action Plan (IAP) and (e) all bill vouchers related to this overseas study to Bangladesh Public Administration Training Centre, Savar, Dhaka;
- She shall sign a bond in a prescribed form before her departure; (f)
- The Selected Government Officials shall depart the country before the date mentioned in (g) this GO. Otherwise this GO will be treated as null & void. In that case alternative candidate will be considered and the previous candidate shall return all the Government money;
