

**Notification**

The undersigned is directed to convey Government's approval of study leave on half of average pay to Ms. Keya Debnath (ID No. 17695), Officer on Special Duty (Senior Assistant Secretary), Ministry of Public Administration from 30.08.2023 to 07.06.2025 for attending Master in Public Policy at The University of Chicago, USA, under the following terms and conditions:

- a. She will start her journey for the USA at a convenient date near to 30 August 2023;
- b. She will draw her pay and allowances in local currency as per Education Leave rule (Half of Average Pay) of the Government. No part of it should be drawn in foreign currency;
- c. All related expenses of the said programme will be borne by herself;
- d. She will not be allowed to stay abroad more than the approved period;
- e. The provision of Appendix V and Rule 194 of BSR (Part-1) is applicable for this approval. Application for further extension of leave to complete the mentioned course will not be considered;
- f. She will have to submit awarded certificate and a report to the Foreign Training Section of the Ministry of Public Administration within five days after her return/completion of the programme;
- g. She is ineligible for applying for permanent residency and citizenship while studying abroad;
- h. All terms and conditions of PATP-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
