 - b) The approved period of this program and the time spent for travel and transit will be treated as on-duty
 - c) She will draw all her pay and allowances in local currency
 - d) All expenses related to this program will be borne by the 'Prime Minister Fellowship' under the "Strengthening the Capacity of Public Administration for Achieving SDGs (SCPA-SDG)" Project, Prime Minister's Office, Dhaka
 - e) She will not be allowed to stay abroad for more than the approved period;
 - f) She will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of her return to Bangladesh after completing the course;
 - g) She is ineligible to apply for permanent residency and citizenship while studying abroad.
 - h) All terms and conditions of PATP-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
