# **Governing Board - Engaged Faculty Consultant**

The Colombo Plan Staff College (CPSC) is an Inter-governmental International Organization for Human Resources Development. It aims to assist its member countries in developing and enhancing their technical education systems.

CPSC maintains the active membership of 16 countries which are provided with capacity building programs in technical and vocational education and training (TVET).

The main functions of CPSC include:

- Provide training programs of further professional education and training to persons responsible for the planning, development, administration and supervision of TVET and persons in key supporting roles;

He/She is a member of the Academic Board, usually assigned as Chairperson of the Training and Development Division, among others.

With the assistance of Team Leaders, and guidance of the Director General, the GB-Engaged Faculty Consultant is responsible for:

- managing the implementation of the regular and extra-budgetary training programs (regional, in-country, international conferences/seminars, special and programs) as may be assigned
- Develop and implement online training programs
- Seeking opportunities for joint programs and projects with member countries and other development partners;

- Preparing theme papers/instructional materials/books on emerging fields of study related to Research and CPSC publications;
- Writing and publishing articles and papers in international journals;
- Undertaking research projects/studies on emerging TVET issues;

- Assisting the Staff College in resource generation through consultancy projects, customized course, international symposia, study visits and other special events;
- Contributing to the activities of the Asia Pacific Accreditation and Certification Commission (APACC);
- Managing the conceptualization and development of CPSC projects from initiation, design, proposal making, marketing, coordination, evaluation and documentation stages
