  - f) He will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of his return to Bangladesh after completing the course;
  - g) He is ineligible to apply for permanent residency and citizenship while studying abroad;
  - h) All terms and conditions of PATP-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


