The undersigned is directed to convey the Government's sanction of deputation and study leave to Mr. A.K.M. - a. The approved period of this course and the time spent for travel and transit will be treated as on duty;
 - b. He will draw all parts of his pays and allowances in local currency.
 - c. All expenses of the said course will be borne by Japanese Grant Aid for Human Resource Development Scholarship (JDS) and by himself.
 - a. He will not be allowed to stay abroad more than the approved period.
 - b. His deputation period is from 19/09/2021 to 22/07/2024.
 - c. Duration of his Education Leave (on half average pay) is from 23/07/2024 to 31/10/2024.
 - d. The provision of Appendix V and Rule 194 of BSR (Part-1) and provision of Rule 34 of BSR (Part-1) will be applicable in connection of this approval.
 - e. After completion of the course he will have to submit a report to the Foreign Training Section of the Ministry of Public Administration.
