

- a. The approved period of this course and the time spent for travel and transit will be treated as on duty;
 - b. He will draw all parts of pays and allowances in local currency;
 - c. All expenses related to this program will be borne by Japan Human Resources Development Scholarship (JDS), Japan;
 - d. This approval includes participating in online sessions in the context of the present COVID-19 pandemic situation as well as on campus study. The permission to participate in online sessions will cease whenever the university decides to commence on campus study;
 - e. He is required to inform Ministry of Public Administration before leaving the country for on-campus studies in Japan;
 - f. His deputation period is from 01/09/2020 to 31/10/2022;
 - g. He will not be allowed to stay abroad more than the approved period;
 - h. The provision of Appendix V and Rule 194 of BSR (Part-1) and provision of Rule 34 of BSR (Part-1) will be applicable in connection of this approval;
 - i. After completion of the course he will have to submit a report to the Foreign Training Section of the Ministry of Public Administration.
