

The undersigned is directed to convey the Government's approval of deputation to Ms. Ayesha Siddiqua (ID No. 17202), Officer on Special Duty (Senior Assistant Secretary), Ministry of Public Administration for attending Master of Environmental Management and Sustainability at Flinders University, Australia from 15.01.2024 to 31.12.2025 under the following terms and conditions:

 - f. She will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of her return to Bangladesh after completing the course
 - g. She is ineligible for applying for permanent residency and citizenship while studying abroad
 - h. All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


