

- (a) Total period of this program and the time spent for travel and transit will be treated as on duty;
 - (b) She will draw all parts of her pay and allowances in local currency;
 - (c) BDT 39,60,000.00 (Thirty Nine Lac Sixty Thousand) (Maximum) will be provided for Master Program from the "Capacity Enhancement of the Core Courses of BPATC" project being implemented under BPATC, Savar, Dhaka and sponsored by DRGA-CF, Government of Japan;
 - (d) She will not be allowed to stay abroad more than the approved period;
 - (e) After completion of the course she will have to submit an Individual Action Plan (IAP) and all bill vouchers related to this overseas study to Bangladesh Public Administration Training Centre, Savar, Dhaka;
 - (f) She shall sign a bond in a prescribed form before her departure;
 - (g) The Selected Government Officials shall depart the country before the date mentioned in this GO. Otherwise this GO will be treated as null & void. In that case alternative candidate will be considered and the previous candidate shall return all the Government money;
2. The Government Order NO 05.00.0000.107.14.019.19-329 dated 03.11.2019 will now be treated as cancelled.
 3. This order is issued with the approval of the competent authority.


