

The undersigned is directed to convey the sanction of deputation order and fellowship to **Mr. Md. Moniruzzaman (BP-7710126771)**, Additional Deputy Commissioner of Police, Professional Standard & Internal Investigation Division (PS & IID), Dhaka Metropolitan Police, Dhaka *Studying* MA (Taught): Social Policy (FT), University of Birmingham, United Kingdom from 27 September 2021 to 26 September 2022 (or from the nearest possible date) excluding transit period under the following terms and conditions:-

- (a) Total period of this program and the time spent for travel and transit will be treated as on duty;
 - (b) He will draw all parts of his pay and allowances in local currency. The Fellowship will cover maximum BDT 50,00,000.00 (Fifty Lac), which will be provided for Master Program from the "Strengthening Government through Capacity Development of the BCS Cadre Officials (Phase-II)" project being implemented under the Ministry of Public Administration, Government of Bangladesh;
 - (c) The selected official will be entitled to enjoy all the benefit of this scholarship as per the project document after full payment of tuition fee directly to the awardee university account from this office;
 - (d) The selected government official shall depart the country before the date mentioned in this GO and he will not be allowed to stay abroad more than the approved period;
 - (e) The selected participant shall submit regularly a Quarterly Study Progress (QSP) report in the prescribed format to this Office;
 - (f) He shall sign a bond in a prescribed format and need to submit the proof of tuition payments before departure from Bangladesh;
 - (g) After completion of the course, he will have to submit an Individual Action Plan (IAP), all bill vouchers related to this overseas study and proof of Air travel with original Boarding passes (Departure-Arrival) to the Ministry of Public Administration and
 - (h) On completion of the said Master's degree, the awardee controlling Govt. office is hereby requested not to place the officer in next posting until a NOC has been provided in favor of the official from this office.
2. This order is issued with the approval of the competent authority.


