  - d) All expenses related to this course will be borne by the Strengthening Public Financial Management Program to Enable Service Delivery (SPFMS), Institute of Public Finance, Bangladesh (IPF), Finance Division;
  - e) The deputation order issued on 22/08/2024 vide memo no. 05.00.0000.202.25.002.24.293 is hereby cancelled and replaced by this order;
  - f) She will not be allowed to stay abroad for more than the approved period, the provision of Rule 34 of BSR (Part-1) will be applicable in connection with this approval;
  - g) She is ineligible to apply for permanent residency and citizenship while studying abroad;
  - h) All terms and conditions of Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable;
  - i) She must submit a report to the Foreign Training Section of the Ministry of Public Administration within five days after her return from/completion of the programme.
