

The undersigned is directed to convey the Government's approval of an extension of deputation to Ms. Nurun Akhtar (ID No. 6538), OSD (Joint Secretary), Ministry of Public Administration for completing her course in Management Information System (MIS) at the New York IT Institute, USA from 24-02-2024 to 31-07-2025 under the following terms and conditions:

- a. The approved period of this programme and the time spent for travel and transit will be treated as on duty;
 - b. She will draw all parts of her pays and allowances in local currency and not in foreign currency;
 - c. All expenses related to this program will be borne by the New York IT Institute, USA;
 - d. She will not be allowed to stay abroad for more than the approved period;
 - e. This order is granted in continuation of her deputation granted vide letter no. 05.00.0000.202.25.009.22.78 dated 01/03/2022;
 - f. She is ineligible to apply for permanent residency and citizenship while studying abroad;
 - g. All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
 - h. She will have to submit a report to the Foreign Training Section of the Ministry of Public Administration within five days after her return from/completion of the programme.
