

The undersigned is directed to convey the Government's sanction of deputation and education leave to Mr. Mohammad Mahabub Alam (ID No. 16282), OSD (Deputy Secretary), Ministry of Public Administration for attending Doctor of Philosophy Course at Australian National University, Australia from 30/06/2021 to 29/06/2025 under the following terms and conditions:

- a. The approved period of this course and the time spent for travel and transit will be treated as on duty;
 - b. He will draw all parts of his pays and allowances in local currency.
 - c. All expenses related to this program will be borne by Australian National University, Australia and by himself.
 - a. He will not be allowed to stay abroad more than the approved period.
 - b. **His deputation period is from 30/06/2021 to 01/07/2024.**
 - c. **Duration of his Education Leave (on half average pay) is from 02/07/2024 to 29/06/2025.**
 - d. **This approval includes online mode of attendance from 30/06/2021 to 30/12/2021 in the context of present Covid19 pandemic. However, he is required to attend on-campus courses in Australia for the rest of the approved period.**
 - e. The provision of Apendix V and Rule 194 of BSR (Part-1) and provision of Rule 34 of BSR (Part-1) will be applicable in connection of this approval.
 - f. After completion of the course he will have to submit a report to the Foreign Training Section of the Ministry of Public Administration.
