

 - f. He will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of his return to Bangladesh after completing the course;
 - g. He is ineligible for applying for permanent residency and citizenship while studying abroad;
 - h. All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
