

The undersigned is directed to convey the Government's approval of deputation to Ms. Marufa Sultana Khan Hiramony (ID No. 18146), Officer on Special Duty (Senior Assistant Secretary), Ministry of Public Administration for attending Master's Degree Program in Economic Development Policy for Sustainable and Inclusive Growth at KDI School of Public Policy and Management, Korea from 21.08.2023 to 20.12.2024 under the following terms and conditions:

- a. She will start her journey to Korea on a convenient date near to 21 August 2023;
 - b. The approved period of this programme and the time spent for travel and transit will be treated as on duty;
 - c. She will draw all parts of her pays and allowances in local currency and not in foreign currency;
 - d. All expenses related to this program will be borne by Korea International Cooperation Agency (KOICA), South Korea;
 - e. She will not be allowed to stay abroad more than the approved period;
 - f. She will submit a report to the Foreign Training Section of the Ministry of Public Administration within five days of her return to Bangladesh after completing the course;
 - g. She is ineligible for applying for permanent residency and citizenship while studying abroad.
 - h. All terms and conditions of PATP-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


